



## LOCAL RULES

### PLAYER'S RESPONSIBILITIES

All players (inc. members) are to check-in at the reception desk before play. It is player's responsibility to maintain good pace of play and keep the distance with group ahead. Players are obliged during their play to maintain the golf course by replacement of divots to their original position, to repair pitch-marks on the greens and when leaving sand traps to return them to the original condition. Play with practice balls or with more than one ball is strictly prohibited. Dress code do not accept players wearing jeans, army clothing, or shirts with no collar or sleeves.

If slow play occurs (gap more than one empty hole ahead) players are to follow marshal's instructions.

Marshal is obliged to first inform player about spotted breach of rules. Players have to realize that repeated negligence of before mentioned actions will be considered a gross breach of ethics as well as of the local rules and players can be penalized and would have to leave the golf course.

### OUT – GOLF COURSE BOUNDS (27-1)

The outer fence of the area was defined as golf course bounds. Players are not entitled to relief at the fence and golf course boundaries. A ball in out is a ball with the entire ball behind the golf course bounds.

### WATER HAZARDS (26)

Longitudinal hazards are marked by red stakes or lines. Lateral water hazards are marked by yellow stakes or lines. A hazard shall be determined by a line and only defined by a stake. In the case of the introduction of a "drop zone" for water hazards, players can proceed according to Rule 26, or take a relief inside the "drop zone".

### GROUND UNDER REPAIR (25-1)

A zone determined by blue stakes or white lines. If this zone is not located in a water hazard, players must take relief with no penalty and to continue according to the Rule 25-1. Relief is related to ball position, stance and space for the intended swing.

### INTEGRAL PART OF THE GOLF COURSE

Continuous shrubs represent an integral part of the golf course and play from such place shall continue with no relief. Players shall be obliged when playing into forest or higher rough to play a provision ball from the original place.

### IMMOVABLE OBSTRUCTIONS (24-2)

All obstructions permanently installed on the golf course: houses, information boards on tees, stabilized and gravel car paths, irrigation installations and their covers. Maintenance car trails are defined as immovable obstructions.

### MOVABLE OBSTRUCTIONS (24-1)

Stakes determining water hazards, ground under repair, distance markers, baskets, ball-cleaners, rakes, banks, directional and information boards (not built in). Stones in sand-traps shall be considered movable obstruction. (24-1)

### USE OF ELECTRIC GOLF CARTS

During tournaments a player asking for use of an e-car must present a recommendation from a doctor. For all e-car users it is strictly prohibited to drive through roughs – outside low-mown parts of the golf course with the exception of tees and greens.
