

PLAYER'S RESPONSIBILITIES

All players (inc. members) are to check-in at the reception desk before play. It is player's responsibility to maintain good pace of play and keep the distance with group ahead. Players are obliged during their to maintain the golf course by replacement of divots to their original position, to repair pitch-marks on the greens and when leaving bunkers to return them to the original condition. Play with practice balls or with more than one ball is strictly prohibited. Dress code do not accept players wearing jeans, army cloths, or shirts with no collar or sleeves.

If slow play occurs (gap more than one empty hole ahead) players have to follow marshal's instructions

Marshal is obliged to first inform player about spotted breach of rules. Players have to realize that repeated negligence of before mentioned actions will be considered as gross breach of ethics as well as of the local rules and players can be penalized and would have to leave the golf course.

PACE OF PLAY POLICIES

It is recommended to apply "Ready Golf". Please follow the pace of play on Score Card or Timing sheet. When group is "out of position" the group must play "Ready Golf". Group is "out of position" when it is over the allocated time for the holes that have been played and not in position with the following group. Maximum Allowable Time of the Round is 4:40h.

PROVISIONAL BALL

Players shall be obliged when playing into forest or higher rough to play a provision ball from the original place.

IMMOVABLE OBSTRUCTIONS (16-1)

All obstructions permanently installed on the golf course: houses, information boards on tees as well as all paved paths and gravel paths on the course, if artificially-surfaced, are treated as immovable obstructions from which relief is allowed under Rule 16.1

MOVABLE OBSTRUCTIONS (15.2)

Stakes determining penalty areas, ground under repair, distance markers, baskets, ball-cleaners, rakes banks, directional and information boards (not built in).

INTEGRAL PART OF THE GOLF COURSE

Continuous shrubs including Trees represent an integral part of the golf course and play from such place shall continue with no relief. Any natural car path except paved or macadam path.

WASTE AREAS

The prepared areas of sand marked as "Waste area" on holes 2,3,4,5,13,15,16 are Waste areas – part of the general area and not bunkers.


NO PLAY ZONES

The area defined by red stakes with green top on left side hole 11 and left side hole 17 is a no play zone. When the ball is in the no play zone within the penalty area, the ball must not be played as it lies and relief must be taken from interference by the no play zone under Rule 17.1e

DROPPING ZONES

As an extra relief option for the penalty area on hole 8, 18 adding one penalty stroke, a player may drop a ball in the dropping zone marked by white line and notification table "Dropping zone" front of the penalty area. The dropping zone is a relief area under Rule 14.3
